2020-2021 NCA Virtual Academy Fees*

Applications and Enrollment Fee:	New Student Application Fee: K-8 \$25.00 (No fees for existing students) \$175.00 per K-8th grade student. Existing Families who are already enrolled in the Academy will not be charged an additional Enrollment fee. This fee covers administrative costs for registration and is paid at the time of online enrollment.
Facilities Fee:	\$0. Existing families who have already paid their facilities fee will receive a credit on their tuition account
Curriculum & Technology Fee:	\$0. Existing families who have already paid their curriculum and Technology fees will receive a credit on their tuition account. Each Family is responsible to provide a computer with internet access and all required system specifics as well as all needed supplemental supplies for their student.

* All Enrollment Related Fees Are Non-Refundable and Are **Not** Pro-Rated for Mid-Year Enrollment or Withdrawal.

Students who are enrolled in the Virtual Academy for the full 9-month school year will receive a 20% discount. The discount will be applied in the last two months of the school year.

NCA Virtual Academy Tuition Payment Options*

Yearly	Prepay for the entire Academic Year prior to September 1, 2020. If you remain in the Virtual Academy for the entire school year you will receive a refund of 20% of your tuition by May 15, 2021 if you have paid in full.
Monthly	Annual tuition is divided into 10-month payments (Sept-June) If your child remains enrolled in the Virtual Academy for the entire year, you will not have to pay your May and June tuition payments in order to receive your 20% tuition credit. <u>All tuition payments are due the 1st business day of the month.</u>
Payment Method*	Automatic (ACH) Form Required, debit/credit card, Bank account withdrawal, cash or check. All credit card transactions thru PayNow or school office Square swipe will incur a credit card convenience fee up to 4%.

- All charges and fees other than tuition will be billed monthly and are payable through PayNow electronic payment options (Family Portal), personal check or cash the first of each month following the month the charges are incurred.
- A \$35 late fee will be applied to accounts not current after the 1st day of each month (including NSF payments).

- Changes to your Enrollment contract or payment plan will result in a \$25 administrative fee charge. Please refer to additional terms and conditions on the Enrollment Contract.
- Transfer fee of \$50 to NCA traditional enrollment if space is permitted and with Administrative approval. NCA Traditional Curriculum/tech and Facilities Fees will be charged. Please refer to the 2020-2021 NCA Tuition and Fee Schedule for more information on fees.



Virtual Academy Application for Existing NCA Families

I grant permission to transfer Enrollment for my child(ren) from Northshore Christian Academy's Traditional School to Northshore Christian Academy's 100% Virtual Academy.
